



# WINTER PARKING REGULATIONS

There are 3 different winter parking restrictions in the City of St Cloud. Therefore, the regulations vary depending upon where you park. Much of the central area of the city is covered by Odd/Even parking restrictions (Seasonal/Calendar Parking). The exception to this is the neighborhood surrounding SCSU which is posted and enforced year-round (see map below). The remainder of the outlying areas of the city is covered by a seasonal parking ban (see section entitled "Seasonal Parking Ban").

## SEASONAL/CALENDAR PARKING

Odd/Even parking regulations are in effect each year from November 1st to April 1st.

These regulations are in effect between 1:00 a.m. and 7:00 a.m., **regardless of the amount of snowfall.**

Between 1-7 a.m., on ODD-numbered days (1st, 3rd, 5th, etc.), you must be parked on the EVEN side of the street. On EVEN-numbered days (2nd, 4th, 6th, etc.) you must be parked on the ODD side of the street. Sides of the street are determined by the house numbers that face that street. **NOTE: If you park your car before midnight, you must remember that the date changes at midnight and you should park accordingly. If you are parked on the wrong side of the street, your vehicle may be ticketed and/or towed.**

EVEN days you park on the NORTH side of streets & the WEST side of avenues.


ODD days you park on the SOUTH side of streets & the EAST side of avenues.

## NO PARKING 1:00 – 7:00 a.m. (SCSU NEIGHBORHOOD)

If you live in the area immediately surrounding St. Cloud State University, you must obey the signs that are posted in this area year-round. The signs will be either "No Parking 1:00-7:00 a.m., Monday-Wednesday-Friday" or "No Parking 1:00-7:00 a.m., Tuesday-Thursday-Saturday."

*If you are parked illegally, your vehicle may be ticketed and/or towed.*



Please note that if you park along Oak Street from 14<sup>th</sup> to 15<sup>th</sup> Avenue SE or along 14<sup>th</sup> Avenue SE from 2<sup>nd</sup> Street SE (CSAH 8) to Oak Street, restrictions have changed and you must follow the signs posted on either side of the street.

### **SEASONAL PARKING BAN**

If you live in any of the following areas, parking is prohibited on city streets between 1:00-7:00 a.m. from November 1st to April 1st. During other hours, parking is allowed as long as the street has been cleared of snow and ice. If the street is paved and less than 32 feet wide, there is no parking any time.

- a) The area north and west of the Sauk River
- b) The area west of the Mississippi River and south of 22nd Street South
- c) The area west of Hwy 15
- d) The area north and east of Hwy 10
- e) The area east of the Mississippi River and south of Hwy 301 and Minnesota Boulevard

If you are parked in violation of this ban, your vehicle may be ticketed and/or towed.

### **SNOW EMERGENCY**

If a SNOW EMERGENCY is declared and you are parked in violation of ANY city ordinance, the vehicle will be **towed immediately** to facilitate plowing. Snow emergencies will be announced on local radio stations, posted continuously on GovTV, and also on the St Cloud City website ([www.ci.stcloud.mn.us](http://www.ci.stcloud.mn.us)).
